Dear Representative Garcia,

I am writing in follow-up to my June 21, 2023, testimony before the House Financial Services Housing and Insurance subcommittee to provide information about the considerable progress that the U.S. Department of Housing and Urban Development (HUD) and Office of Inspector General (OIG) have made in resolving HUD OIG recommendations. Since I became the Inspector General in 2019, one of my top priorities has been to collaborate with the Department to resolve findings from our prior audits and evaluations and take needed corrective action to close outstanding recommendations. This collaboration has resulted in the resolution of numerous, older recommendations, while simultaneously focusing the attention of HUD management on resolving and closing Priority Open Recommendations.¹

When I began serving as Inspector General, HUD had more than 2,100 open OIG recommendations. During my tenure, we have issued more than 1,000 additional recommendations. I am proud to say that through continued collaboration with HUD, we have reduced the total count of open recommendations to 991 as of May 31, 2023.

The following graph demonstrates the progress that HUD and HUD OIG have made in reducing open recommendations, beginning with the Semiannual Report to Congress for the period ended March 31, 2017. The number of open recommendations began to trend downward upon my becoming the Inspector General and has consistently trended downward throughout my tenure. This is a testament to the consistent, collaborative efforts of HUD and HUD OIG career staff and leadership.

As demonstrated by the chart below, of the 991 HUD OIG recommendations that were open as of May 31, 2023, half were issued in 2017 and prior. My office continues to diligently work with HUD to resolve and close older as well as more current recommendations.

We attribute the progress of resolving and closing recommendations, in part, to a collaborative, sustained effort between HUD and my staff, as well as the sustained efforts of successive administrations to close HUD OIG recommendations. For example, we established a joint Tiger Team with HUD's Office of the Chief Financial Officer in August 2020 to regularly conducts rapid resolution activities on aged open recommendations.²

My office also enhanced its internal processes to better support recommendation closures. For example, we established an automated monthly reporting process as well as developed a dashboard that assists my office to identify and target open recommendations that can be resolved. Similarly, HUD has also taken additional steps to close recommendations such updating policy initiatives to support the reduction and management of open recommendations.

As mentioned during my testimony, my office also recently began issuing Priority Open Recommendation resources, including a standalone report and interactive dashboard. These highlight the recommendations that we believe will result in significant, positive impact on HUD

and its beneficiaries and should be prioritized. HUD has resolved and closed several priority recommendations since the report was issued.
