No.	OTHER TYPES OF SIGNIFICANT ACTIVITIES (Completed/On-Going During Reporting Month)
1	June 4, 2009 - CHICAGO, IL: OIG managers gave presentations to HUD's Housing Homeless Prevention and Rapid Re-Housing Program (HPRP) grantees. HPRP is funded under ARRA.
2	June 4, 2009 - CAMBRIDGE, MA: Outreach was provided at the New England Intergovernmental Audit Forum.
3	June 4, 2009 - Reviewed Notice of Funds Availability for Neighborhood Stabilization Act.
4	June 5, 2009 - FORT WORTH, TX: OIG staff presented HUD-OIG perspective on American Reinvestment and Recovery Act to approximately 50 Community Planning and Development recipients and staff.
5	June 9, 2009 - MERRIVILLE, IN: Region V - OIG Managers made presentations and discussed the Public Housing Capital Fund program funded by the American Recovery and Reinvestment Act of 2009 at the Indiana NAHRO Chapter's conference. Both presentations included accountability and reporting requirements of the Act.
6	June 11, 2009 – CONCORD, NH: OIG staff provided fraud detection training to the New Hampshire Community Development Finance Authority (CDFA) staff and to the sub-grantees of the New Hampshire Neighborhood Stabilization Program (NSP I & II).
7	June 11, 2009 - GALLUP, NM: OIG Managers spoke before 175 tribal members from the Navajo Reservation about what they could and could not do with their Recovery Act funds.
8	June 16, 2009 - SAN FRANCISCO, CA: OIG Managers briefed Congressional representatives who were interested in OIG's viewpoint of the Recovery Act and their oversight on HUD's obligations and expenditures at a Congressional Briefing.
9	June 16 – ATLANTA, GA: OIG managers gave a presentation to Homeless Prevention and Rapid Rehousing program participants.
